TRANSIT PLANS

DESCRIPTION:

The Committee is in receipt of the following:

1. County Communication No. 04-288, from the Director of Transportation, requesting an opportunity to provide an update on the status of the five-year bus transit implementation plan.
2. County Communication No. 05-76, from the Director of Transportation, transmitting the "County of Maui Short Range Transit Plan Final Report" dated January 2005 by Urbitran Associates, Inc. The report contains planning, policy, and financial components that provide direction for implementing a public transportation system.
