APPLICABILITY OF CHAPTER 2.80A AND CHAPTER 2.80B, MAUI COUNTY CODE, TO NON-DECENNIAL COMMUNITY PLAN AMENDMENTS

DESCRIPTION:

The Committee is in receipt of the following:

1. Miscellaneous Communication, dated June 8, 2005, from the County Clerk, relating to the applicability of Chapter 2.80A and Chapter 2.80B, Maui County Code, to non-decennial community plan amendments.
2. Correspondence dated July 19, 2005, from the Department of the Corporation Counsel, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 2.80B, MAUI COUNTY CODE, RELATING TO THE PROCESSING OF NON-DECENNIAL AMENDMENTS TO THE COMMUNITY PLANS". The purpose of the proposed bill is to clarify that all applications for community plan amendments filed and complete on or after March 4, 2004 shall be subject to Chapter 2.80B, Maui County Code, but that the requirements for a public hearing in the relevant community plan area and for Council action within one year shall apply only to amendments of community plans enacted pursuant to Section 2.80B.090, Maui County Code.
