Chair and Members:

Your Parks and Economic Development Committee, having met on June 16, 2005, makes reference to County Communication No. 05-206, from Councilmember Charmaine Tavares, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 18.16.320, MAUI COUNTY CODE, AS IT PERTAINS TO THE SEMIANNUAL REPORT REGARDING PARK DEDICATIONS".

The purpose of the proposed bill is to identify the required information to be included in the semiannual report on park dedications.

Your Committee notes that Section 18.16.320(L) of the Maui County Code was established by Ordinance No. 3158, which became effective on February 6, 2004. Among other elements, Section 18.16.320(L) requires the Department of Parks and Recreation to submit semiannual reports on park dedications to the Council, including the quantity of dedicated money and land.

At its meeting, your Committee met with the Deputy Director of Parks and Recreation; the Planning and Development Division Chief, Department of Parks and Recreation; and a Deputy Corporation Counsel.

There was no public testimony.

The Vice-Chair of your Committee explained that the proposed bill was a result of discussions on this matter during a meeting of the prior Council's Parks and Agriculture Committee. She further explained that the bill was necessary to ensure that the semiannual report that is transmitted to Council contains certain information regarding park dedications, including the name of the subdivision, the number of units in the subdivision, and a description of the land area, sum of money, or park improvements, or combination thereof, dedicated or provided.

Your Committee voted to recommend passage of the proposed bill and filing of the communication.
