**PW-15 DEDICATION OF ROAD WIDENING LOT FOR LEVAL TRACT
(WAILUKU)**

FOR UNDERGROUND PRIVATE WASTEWATER SYSTEM PURPOSES”. The purpose of the proposed resolution is to grant a non-exclusive easement to build, construct, reconstruct, rebuild, repair, operate, maintain, relocate or remove an underground private wastewater system through and under a portion of Front Street in Lahaina, Maui.
