

FIRST SUPPLEMENTARY PROCLAMATION

By the authority vested in me as Mayor by the Revised Charter of the County of Maui (1983), as amended, and the Constitution and laws of the State of Hawaii, in order to provide relief for disaster damages, losses, and suffering, and to protect the health, safety, and welfare of the people, I, ALAN M. ARAKAWA, Mayor of the County of Maui of the State of Hawaii, hereby determine, designate, and proclaim as follows:

WHEREAS, Chapter 127A, Hawaii Revised Statutes (“HRS”), empowers me as Mayor of the County of Maui of the State of Hawaii, as the sole judge that an emergency or disaster has occurred or of the existence of imminent danger or threat of an emergency or disaster in any portion of the County of Maui; and

WHEREAS, I declared an emergency on February 23, 2018, due to extensive rains and flooding which occurred throughout the island of Maui beginning on February 18, 2018, and in anticipation of recurrent heavy rains and saturated ground, such emergency period was declared through April 24, 2018; and

WHEREAS, the County of Maui has continued to experience bouts of heavy rain, ongoing saturated grounds, and flash flood warnings (in the last 60 days there have been 10 Flash Flood Warnings, 20 Flash Flood Advisories and 4 Flash Flood Watches issued) and in anticipation of the continuation of this extremely wet weather pattern, which presents an ongoing risk of flooding and associated consequences which may endanger the health, safety, and welfare of the people, and the ongoing need for action by government agencies and representatives from the private sector to provide immediate services to our island residents to ameliorate and mitigate hazardous situations which may continue from the prior flooding event and be compounded by ongoing heavy rains and saturated grounds, and based upon the expertise available to me, I have determined that an imminent danger of death, injury, and property damage to both visitors and residents of Maui County continues, and it has become necessary to supplement the Proclamation of February 23, 2018, in order to extend the period of time required to protect public and private property, residents and visitors from floods, flood debris, and other hazards associated therewith.


NOW, THEREFORE, pursuant to Chapter 127A, Section 14(b), HRS, I, ALAN M. ARAKAWA, Mayor of the County of Maui, do hereby further determine that there presently exists an ongoing threat of imminent danger due to past flooding, saturated grounds, and recurrent heavy rains throughout the County of Maui, and I DO HEREBY PROCLAIM that all of the provisions of the Proclamation of February 23, 2018, shall remain in full force and effect and are hereby included in the provisions of this First Supplementary Proclamation. I further declare and proclaim that the disaster emergency relief period shall continue through June 7, 2018, and that any projects initiated under the original Proclamation or this First Supplementary Proclamation, shall continue to be subject to this First Supplementary Proclamation until project acceptance and any final accounting or payment obligations, whichever is later. Pursuant to this First Supplementary Proclamation, I hereby exercise any and all powers listed in Chapter 127A, Sections 12 and 13, HRS.
