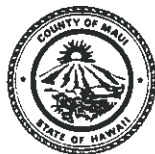

Amendment to Title MC-12, Department of Planning,
Subtitle 02, Maui Planning Commission,
Chapter 201, Rules of Practice and Procedure

1. Section 12-201-28, Rules of Practice and Procedure for the Maui Planning Commission, is amended to read as follows:

“~~§12-01-28~~ §12-201-28 Attendance. No member shall be absent for the service of the commission, unless the member is sick or otherwise unable to attend and has so advised the chairperson prior to the meeting. In accordance with subsection 13-2.5 of the revised charter of the County of Maui (1983), as amended, the chairperson shall request that the mayor recommend to the council the removal of any member who misses 50 percent or more of the commission’s regular meetings over any 120-day period.” [Eff 7/25/93; am and comp 07/02/2020] (Auth: HRS §91-2) (Imp: HRS §91-2)


2. Material, except source notes, to be repealed is bracketed. New material is underscored.
