- (1) The goods, services, or construction has the following unique features, characteristics, or capabilities:

Accuracy - ~94.7% sensitivity and ~98.6% specificity, when compared to two different lab-based PCR reference tests.

Affordable and available - 10 analyzers for Maui outpatient clinics. Cost is ~\$4500 for each machine (TOTAL \$45,000).

\$30,000 for patient test kits other consumables and shipping 3-4 wks. Apportionment of tests will depend on patient load.

- (2) How are the unique features, characteristics, or capabilities essential for the agency to accomplish its work:

Maui County urgently needs increased COVID testing capacity with rapid Turn Around Time (TAT) for results.

Abbott ID Now system will provide Maui outpatient clinics with increased test capacity and TAT of ~15 minutes.


