Pursuant to Chapter 103D, Hawaii Revised Statutes, sealed bids shall be RECEIVED ELECTRONICALLY and recorded immediately via the **Public Purchase System** until **2:00 PM (Hawaii Standard Time), on Wednesday, November 18, 2020**. Bids shall be submitted via the **Public Purchase System**, otherwise the bids shall not be opened or considered. Bids received after the time fixed for opening will also not be considered.

The project involves furnishing all labor, tools, materials and equipment as necessary to re-coat the interior of a 96-foot diameter circular concrete water tank. Work to include concrete surface preparation and surface coating and erecting a temporary steel water tank with inflow & outflow piping and other project related improvements, in place complete.


A non-mandatory pre-bid meeting will be held at 9:00 AM on Wednesday, October 28, 2020 via BlueJeans teleconferencing. Following the meeting, at 10:30 AM a site visit will be conducted and interested parties shall meet at the Department of Water Supply, Central Baseyard, 614 Palapala Drive, Kahului, Maui, Hawaii 96732. Interested parties requesting to attend the meeting or site visit are required to provide notification of attendance by email to DWS.Engineering@mauicounty.gov at least THREE (3) days prior to the designated date.

Bid documents for this project are available through a web-based e-procurement system. To view and download bid documents you will need to follow instructions described at www.co.maui.hi.us/DocumentCenter/View/91025. Bid documents will not be available at the Purchase Division offices. Any questions pertaining to the process, or helping in submitting a bid, can be directed to Jared Masuda at (808) 463-3816. All questions regarding the bid documents shall be in writing and submitted to DWS Engineering Division no later than TEN (10) calendar days prior to the Bid Opening date.

Bidders shall possess applicable and valid State of Hawaii contractor's licenses to perform the work and valid at the time of bid opening. Required licenses that are applicable in part or in whole are the following: "A" License, C-33, C-33c, C-37d, C-55 and C68 – Tank Erector.

Bids must be accompanied by an acceptable form of bid security in an amount not less than five percent (5%) of the amount of the base bid, including additives, payable to the "**County of Maui**" and in compliance with Section 103D-323, Hawaii Revised Statutes, as amended.

Bidders are required to comply with the newest procurement code Hawaii Revised Statutes Chapter 103D, any rules and regulations and policy directives issued with respect to Chapter 103D, and any amendments thereof.
