The Taser X2 is a conductive energy weapon that uses electrical current to disrupt voluntary control of muscles which means that it interrupts the ability of the brain to control the muscles of the body. This creates an immediate and unavoidable incapacitation that is not based on pain and cannot be overcome. This is described by Axon Enterprise Inc. as "neuromuscular incapacitation."

(2) How the unique features, characteristics, or capabilities are essential for the agency to accomplish its work:

The Taser X2 model has the following features: a pre-loaded backup shot to lessen missed shot or to also engage multiple targets, a warning arc feature which when displayed helps prevent conflicts from escalating, and current metering which measures and accurately delivers the precise amount of current.
