- (1) The goods, services, or construction has the following unique features, characteristics, or capabilities:
The Wastewater Reclamation Division (WWRD) has standardized on Danfoss motor controllers. Only spare motor controllers and associated parts for Danfoss are kept in inventory. Technicians are exclusively trained on Danfoss motor controllers.

- (2) How are the unique features, characteristics, or capabilities essential for the agency to accomplish its work:
Wastewater is an essential service. Proper training, spare parts, and identical mounting hardware and connections are critical to providing reliability. WWRD may only provide this critical reliability with the inventory of spare parts and training built around a single manufacturer, Danfoss.


- (3) The following other possible sources for the goods, services, or construction were investigated but do not met our needs because:
