requirements due to COVID-19

The only access to this religious institution is through the Wailuku municipal parking lot.

For the safety of the staff, congregation and construction crew during the development

of the parking structure this access had to be closed. To prevent disruption of the church

operations, an alternative location in Wailuku was required until access is restored.


- (3) The following other possible sources for the goods, services, or construction were investigated but do not meet our needs because:
