Judge Netting, Inc. offers a 10 feet high litter barrier fence that is used at the landfill down wind of the active working area to collect litter. The fences are easily installed, but also easily relocated to adjust to changing environmental conditions.

The litter barriers are essential to minimize litter from leaving the site and allow the County to be compliant with its Hawaii Department of Health Solid Waste permit.
