The batteries provide backup power to the communication equipment at the sites in the event of the failure of commercial generator power. The site batteries are part of the County's Motorola Radio System and Banyan Networks is the authorized Motorola service provider for the County's Motorola Radio System.

- (2) How the unique features, characteristics, or capabilities are essential for the agency to accomplish its work:

The backup batteries are an essential part of maintaining power to the County's Radio System during times of emergency. The replacement of the batteries needs to be performed by authorized service providers, Banyan Networks in this case, to ensure that the communication equipment is not damaged when the batteries are replaced.

(3) The following other possible sources for the goods, services, or construction were investigated but do not meet our needs because:


