## ESTABLISHING A SISTER-CITY RELATIONSHIP WITH THE MUNICIPALITIES OF SANTA AND SAN JUAN, PROVINCE OF ILOCOS SUR, REPUBLIC OF THE PHILIPPINES

WHEREAS, Section 46-9, Hawaii Revised Statutes, authorizes the County of Maui, State of Hawaii, United States of America, to establish ties of friendship, understanding and goodwill with Sister Cities by resolutions duly adopted by the Council of the County of Maui; and

WHEREAS, the Municipalities of Santa and San Juan, Province of Ilocos Sur, Republic of the Philippines, have expressed interest in forming a Sister City relationship with the County of Maui to strengthen the ties between the United States of America and the Republic of the Philippines; and

WHEREAS, because of the common interests and the multitude of similarities, Mayors Linda Crockett Lingle, Jose V. Bello IV and Benjamin V. Sarmiento, agree that a Sister-City relationship will be of mutual benefit; and

WHEREAS, the County of Maui is pleased and honored by the proposal to enter into a Sister-City relationship with the Municipalities of Santa and San Juan, to provide for the sharing of theories, methodologies and practicalities on matters of economic development, mutual trade, education, culture exchange and other activities to promote friendship, understanding, and goodwill; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it hereby authorizes Mayor Linda Crockett Lingle to formalize a Sister-City relationship between the County of Maui and the Municipalities of Santa and San Juan, Province of Ilocos Sur, Republic of the Philippines, for the purpose of strengthening the bonds initiated through cultural, business, and economic exchanges, furthering the ties of friendship and understanding, and promoting enduring goodwill between the people of the United States and the people of the Republic of the Philippines; and

Bello IV, Municipal Mayor, Municipality of Santa, Province of Ilocos Sur, Republic of the Philippines; the Honorable Benjamin V. Sarmiento, Municipal Mayor, Municipality of San Juan, Province of Ilocos Sur, Republic of the Philippines; the Honorable Linda Crockett Lingle, Mayor of the County of Maui; and Mr. Mufi Hanneman, Director of International Affairs.
