Fees provide for Residential Solid Waste Services which include curbside refuse pick up, landfill operations, vehicle maintenance and staffing. To open a Residential Solid Waste account, please fill out this application and include payment upon submission.

Fees for Residential Solid Waste Services are \$408* (**\$204 for Lanai**) per year and are billed semi-annually in June and December. The billing cycles are July 1 to December 31 with \$204* (**\$102 for Lanai**) payable by June 30 and January 1 to June 30 with \$204* (**\$102 for Lanai**) payable by December 31. If opening an account mid-cycle, submit payment based on \$34* (**\$17 for Lanai**) per month for the remainder of the current cycle. For example: An account opened in March would be charged for four months (March, April, May, June). A payment of \$136 (4 x \$34) [**\$68 (4 x \$17) for Lanai**] would be included with this application. There is no prorating for partial months of service. Please note that there is a \$30 Service Fee to reopen any account disconnected for non-payment of balance by due date.

Solid waste service address and account # (for renewals) must be written on a check made out to "County of Maui" and mailed to: Solid Waste Accounts Office, County of Maui, 2200 Main St, Ste 200, Wailuku, HI 96793

Walk-in payments are posted until 2:30 pm. We are located at One Main Plaza, 2200 Main St, Suite 200, Wailuku, 270-7720. Cash and checks are accepted.

Automated Collection Routes

Each account is issued one 95-gallon cart with wheels. All solid waste must be placed within the cart with the lid closed. Carts must be placed according to guidelines (www.mauicounty.gov/763/Automated-Residential-Collection-Guideli) or they will not be picked up. Automated routes will receive twice (**once for Lanai**) weekly pickup, but if possible, place all solid waste in the cart on your first pick-up day of the week. Pick-up will occur between the hours of 5:00 am to 3:30 pm. Carts are the property of the County of Maui and a fee of \$105.00 will be assessed for a replacement. An additional cart can be issued if there is a second dwelling (Ohana with a separate roofline) on the property and an additional account is opened and paid for.

Manual Collection Routes

Please accept our "Opalagies" if your street is not automated at this time. The new larger trucks cannot travel on some streets. Each account is allowed up to six containers which are picked up once a week. A container may be a trash can, bag, box, or bundle not to exceed 32 gallons or 50 pounds. Bags or boxes placed on top of trash cans are counted as separate containers. Please label your rubbish containers with your house number.
