PURSUANT TO CHAPTER 103D, HRS, SEALED BIDS for **SOUTH MARKET STREET SIDEWALK IMPROVEMENTS (FY '13), JOB NO. 13-43, ISLAND OF MAUI**, will be received and **time stamped** by the Bid Receiver, Purchasing Division, Department of Finance until 2:00 P.M. on

Wednesday, October 15, 2014

at which time and place the sealed proposals will be publicly opened and read.

Bids shall be received at the Wells Street Professional Building, 2145 Wells Street, Suite 104, Wailuku, Hawaii 96793. Bids shall be submitted in a sealed envelope, and shall be on the Proposal Form provided on the compact disc furnished by said Department. Bids received after the established due date and time will not be considered.

This project involves removal of roadway improvements; removal of pavement by cold planing; adjustment to existing utility covers; installation of hot mix asphalt pavement, speed hump, pavement markings and markers, signs, curbs, curbs and gutters, sidewalk, driveways, curb ramps, drainage improvements; and other associated work.

Bids shall be submitted in a sealed envelope, and shall be on the Proposal Form provided with the specifications. Bids received after the established due date and time will not be considered.

To be eligible for award, bidders must possess a valid State of Hawaii General Engineering Contractor's "A" license or General Building Constructor's "B" License or Specialty Contractor's "C-?" license, prior to the award of the contract. Bidders shall be licensed in accordance with Chapter 444, HRS, relating to the licensing of contractors :

The Hawaii Products Preference pursuant to Act 175, SLH 2009 is applicable to this project. Persons wishing to certify and qualify a product as a Hawaii Product shall submit a Certification for Hawaii Product Preference (SPO form 38) for each product to Purchasing Division no later than **October 3, 2014** - 10 days before bid opening. Late submittals for this solicitation will not be reviewed by the County.

Contractors are hereby notified of the applicability of Section 11-205.5, HRS, which states that campaign contributions are prohibited from specified State or County government contractors during the term of the contract if the contractors are paid with funds appropriated by the legislative body.

The County of Maui, in accordance with the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252) and the Regulations of the U.S. Department of Transportation (Title 49, Code of Federal Regulations Part 21) issued pursuant to such Act, hereby notifies all bidders

that it will affirmatively insure that the contract entered into pursuant to this advertisement will be awarded to the lowest responsible bidder without discrimination on the grounds of race, color, religion, sex, national origin, age, or disability.


The Equal Employment Opportunity Regulations of the Secretary of Labor implementing Executive Order 11246, as amended shall be complied with on this project.

Each proposal shall be on a form furnished by the Department of Public Works, County of Maui. The proposal guaranty shall be equal to **at least** five percent (5%) of the total amount of the bid submitted.

Estimated construction cost is between **\$300,000 to \$500,000.**
