1. Bid Documents for Sealed Bids to furnish all labor, tools, materials, and equipment for road resurfacing by Waihee School for the Department of Water Supply, County of Maui, shall be subject to the General Provisions, Special Provisions, Offer Form and General Conditions (bid documents).
2. Offer shall include all applicable taxes, except Federal Excise Tax from which the County is exempt.
3. SUBMISSION OF PROPOSAL
Each bid, intact and bound with the Bid Documents shall be enclosed in a sealed envelope and delivered to the Department of Water Supply, County of Maui, as indicated in the official advertisement at the address name in the advertisement. The outside of the envelope shall be plainly marked as follow:

 - c. to increase or decrease the quantities anytime prior from the charges.

6. A contract shall be awarded to the lowest responsible and responsive bidder.
7. A performance and payment bond is required. No bid bond is required.

1. Map of the location. The TMK is 3-2-007:021, address is 2125 Kahekili Highway. The size of the resurfacing is 27 feet by 15 feet.
2. Since school is in session, work should be done at times with minimal noise and traffic impact to the school and students.
3. Compaction testing as required by State of Hawaii Department of Transportation if required include permits or plans.
4. Contractor must have an A license.
5. All trenches must be repaved to County of Maui, Department of Public Works Standards which includes the 2005 Hawaii Standards Specification.
6. Prevailing Wages.
7. All preparation of materials is the responsibility of the bidder. The Department of Water, County of Maui will mark the trenches with a "X" mark and boundary lines to identify each patch.
8. 12 inch of AC.
9. 8 inch of Base (UTB) and 12 inch Sub Base.
10. Permanent road striping.
11. Trench restoration details.
12. Traffic control plan.
13. Complete State Department of Transportation Permit Application.
14. All trenches must be repaved to State Department of Transportation standards.
